



Welcome to Java's Veterinary Center's Boarding Facility!

Thank you for choosing to board your pet(s) with Java's Veterinary Center. Please read over our boarding policies to ensure that our services match your needs. Please initial each statement acknowledging that you have read, understand, and accept the terms of these policies.

VACCINE REQUIREMENTS:

_____ *JVC requires your dog be vaccinated for bordatella. If you cannot show proof of a valid bordatella vaccine, your dog will be given the vaccine at current pricing. An additional charge of \$5.00 per day will be assessed due to the necessity of keeping your pet separated from the other pets, as the vaccine takes time to become effective. This vaccine prevents the spread of a very contagious disease known as kennel cough. This policy has been created for the safety and protection of everyone's pets while boarding in this facility.

_____ *JVC also requires that your dog be current on DHPP (Distemper) and rabies. Cats must be current on FVRCP (Distemper), FeLV (Leukemia) and rabies. Proof of these vaccines is mandatory, so please check the expiration dates on your shot records and/or obtain these records from your veterinarian **BEFORE** your arrival. If proof is not provided of current vaccines, JVC will administer these vaccines for your pet at current pricing.

_____ *If you have lost your proof of current vaccines, it is **YOUR RESPONSIBILITY** to contact your veterinary clinic to get copies of these records **BEFORE** your arrival. They may be faxed to our clinic. Fax: 315.764.0969

HYGEINE:

_____ *If your pet is admitted with fleas and/or ticks, JVC will apply flea medication (Advantage, Advantix or Frontline) as to stop the spreading of fleas, ticks and eggs throughout the facility. You will be charged for the medication at current pricing as well as an additional \$10 for a cleaning charge. It is your responsibility to ensure that your pet is flea-free before admittance to the facility.

_____ *If your pet is admitted in an unclean manner (for example: covered in dirt, straw, weeds, sawdust, etc.), JVC reserves the right to bath your pet at a **minimum \$50.00 charge** for bathing and **an additional \$10.00 facility cleaning fee**.

PAYMENT REQUIREMENTS:

_____ *JVC is a **CASH OR CHECK ONLY** facility & payment for services is due upon admittance of your pet.

_____ *JVC charges \$15/day per pet/ per day- all vaccinations must be current- **NO EXCEPTIONS**.

_____ *JVC charges an additional \$5.00/day for administering medications/if pet in heat/ineffective bordatella. An additional charge of \$20-\$25 may be incurred for those animals with behavioral problems.

_____ * Drop-off is between **8:00 am and 3:00 pm Mon-Sat.**

_____ *Pick-up is at **8:00 am sharp, Sun-Sat**. JVC runs on an 8am-8am schedule, therefore if you pick up your pet past 8am, you will be charged for that same day. Any late fees are due immediately upon pick up of your pet.

BOARDING AGREEMENT

Java's Veterinary Center, LLC (called "Java's"), with an address of State Highway 56, Massena, New York 13662 hereby agrees to board your pet under the following terms and conditions:

Java's hereby agrees to board your Pet and to use reasonable care to prevent injury and illness to your Pet. Boarding will include regular watering and feeding of your Pet. Any additional services shall be done only with the agreement of Java's and may include additional fees. If Java's determines that veterinary care or medication is required they may arrange for or provide such service or medication and Owner shall be responsible for the usual and customary cost thereof.

Java's liability under this agreement shall be limited to the lesser of the current chattel value of an animal of the same species as Pet or \$500.00. Owner is responsible for all acts of Pet while Pet is boarded at Java's, including injury, death, or damage to persons or property.

The Owner agrees to pay all boarding charges, veterinary bills, medication expenses, and all costs for damages caused by Pet before Pet leaves Java's kennel premises. In the event the Pet is not picked up on the agreed upon pick up day and all amounts due and owing aren't paid, Owner agrees that Java's may assert a lien for the said amounts and may withhold delivery of Pet. In addition, Java's may dispose of Pet at public or private sale to cover any such amounts due. In addition, Owner shall be responsible for Java's costs enforcing the terms of this agreement, including but not limited to reasonable attorney's fees.

This agreement shall apply to all stays by Pet at Java's now or in the future. In addition, this agreement shall apply to any pet of Owner boarded with Java's. No part of this agreement shall be modified except in writing signed by both parties. This agreement shall be binding on Owner's heirs, administrators, personal representatives, and/or assigns and constitutes the entire agreement of the Parties.
